#### 1.1 Tenure Information

Santos QNT Pty Ltd is the holder and operator of Petroleum Lease (PL) 303.

PL 303 was granted on 8 April 2013 for a 21 year term which expires on 7 April 2034. The permit area comprises 21 sub-blocks.

#### 1.2 General Information

This report contains information to satisfy the *obligation* to lodge an Infrastructure Report pursuant to section 552 of the *Petroleum and Gas (Production and Safety) Act 2004* (Qld).




Figure 1. Block Identification Map - PL 303

## 2. Authorised Activities

#### 2.1 Details of the authorised activities for the lease carried out in previous financial year

Since the last financial year (1 July 2014 to 30 June 2015), the operator has carried out the following authorised petroleum activities:

- Drilled wells Cuisinier 17, 18, 19, 20 and 21;
- Completed wells Cuisinier 13, 14, 15, 16, 20 and 21;
- Executed cased hole evaluation in well Cuisinier 17 and status is suspended;
- Plugged and abandoned well Cuisinier 18;
- Suspended well Cuisinier 19;
- Laid down pipelines to connect recently drilled wells to gathering facilities; and,
- Connected wells Cuisinier 13, 14, 15, 16, 20 and 21

## 3. Infrastructure and Works Carried Out

3.1 Details of infrastructure and works constructed in the area of the lease in the previous financial year, including the location of the infrastructure and works.

The following infrastructure is located within PL 303:

- 20 producing wells and their related pipe work (Cuisinier 1-16, Cuisinier 20-21, Cuisinier North 1, Barta North 1);
- 1 abandoned well (Cuisinier 18) and 2 cased & suspended wells (Cuisinier 17 & 19)
- Two Multi Port Valves (MPV) (located on the Cuisinier 1 lease);
- One Multi Port Valve (MPV) (located on the Cuisinier 6 lease);
- One Multi Port Valve (MPV) (located on the Cuisinier 10 lease);
- One Gas-Liquid Cylindrical Cyclone (GLCC) Separator Vessel (located on the Cuisinier 1 lease)




Figure 2. Infrastructure Map - PL 303
